- 1. GEM Securities involve a high investment risk. In particular, companies may list on GEM with neither a track record of profitability nor any obligation to forecast future profitability. GEM Securities may be very volatile and illiquid. 創業板證券涉及很高的投資風險。尤其是該等公司可在無需具備盈利往績及無需預測未來盈利的情況下在創業板上 市。創業板證券可能非常波動及流通性很低。
- 2. I/We should make the decision to invest only after due and careful consideration.
