**Statement on Fraudulent Websites
For CASH and CFSG**

(Hong Kong, 17 August 2020) – Celestial Asia Securities Holdings Limited (“CASH”) [SEHK: 1049] and CASH Financial Services Group Limited (“CFSG”) [SEHK: 510], would like to alert investing public and clients to the following suspicious fraudulent websites:

These fraudulent websites unlawfully use the phone numbers and other corporate details of CASH and CFSG, with anonymous hyperlinks and addresses not related to any of CASH or CFSG.

Investing public and clients are reminded that the above-mentioned websites or companies have no affiliation or connection whatsoever with CASH, CFSG or any of their subsidiaries. They are strongly advised not to click on any of these suspected or fraudulent websites. Any suspicious e-mails or web links received should be deleted immediately to prevent computers from viruses or fraudulent use of personal information. Both CASH and CFSG do not accept any responsibility for these websites or the content thereof.

If the investing public and clients are concerned that they may have disclosed personal information to or conducted any financial transactions through these fraudulent websites, they are highly recommended to report to their local police.

The two companies reiterate that the operation of their official websites and relevant online trading services are normal. The official website of CASH is www.cash.com.hk while CFSG is www.cfsg.com.hk. CFSG clients are reminded to get access to their internet trading accounts by keying in or bookmarking the official website address.
